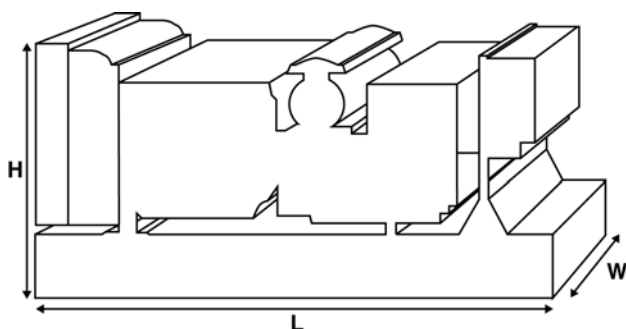
Standby Rating
